Breaking Free from Consolidation



Technical Highlights

After peaking in early May 2024, the stock entered a broad-based market consolidation, eventually retreating to its 52-week low. While an initial rebound attempt followed, the lack of sustained buying interest led to another consolidation phase, forming a declining channel pattern as the stock traded within the range. Recently, bullish momentum has resurfaced, with the stock showing multiple consecutive green candles, signalling a shift in sentiment. At last Friday's close, the stock successfully broke out of the channel pattern and moved above its 20-day EMA. With these positive technical, we think this forms the groundwork for the stock to initiate trend reversal.

Momentum indicators are favourable. The RSI accelerates from the oversold zone, indicating the resurgence of strong buying interest. Meanwhile, the display of the golden cross in the MACD last Friday's closing reaffirmed the stock's short-term bullish outlook.

A pullback to the RM2.08-RM2.10 range would provide a good entry opportunity. Should the stock maintain its bullish momentum and successfully break above the key resistance at RM2.17, it could trigger an extended move toward the next resistance target at RM2.30. Conversely, a break below RM1.97 would indicate a false breakout, potentially leading to a new consolidation phase.

Breakout & EMA Bullish Confirmation



Technical Highlights

The stock has been on a downtrend since early October 2024. During this period, the stock showed no sign of recovery as the buying interest remained weak, with the RSI hovering in oversold territory. Recently, the reignition of buying interest propelled the stock higher and broke out of the falling triangle pattern. Post-breakout, the stock sustained its bullish momentum, continuing its uptrend formation. At last Friday's closing, the buying interest surged to 2.6x the 90-day average, leading the stock to close significantly higher with the formation of a large bullish green candle. Additionally, the stock also closed above all its key EMAs, supporting the case of potential trend reversal over the horizon.

Momentum indicators are strengthening. The RSI continued to trend upward, signalling sustained buying interest. Meanwhile, the recent formation of the golden cross also ascertained the build-up of the stock's positive momentum.

An ideal entry lies within the RM0.600 to RM0.625 range. If trading momentum persists, the stock may challenge its nearby resistance at RM0.645. A successful breakout at this level would form the stage for the stock to test its next target at RM0.685. On the other hand, a decline below the recent support at RM0.585 would invalidate the stock's trend reversal, potentially leading to consolidation.

Glossary of commonly used technical terms

Exponential Moving Average (EMA)	An indicator frequently used in technical analysis showing the average value of a security's price over a set period with greater weightage placed on the most recent data points.
Moving Average Convergence Divergence (MACD)	A trend-following momentum indicator that shows the relationship between two moving averages of prices. The MACD is calculated by subtracting the 26-day exponential moving average (EMA) from the 12-day EMA. A 9-day EMA of the MACD, called the "signal line", is then plotted on top of the MACD, functioning as a trigger for buy and sell signals.
Stochastic	A technical momentum indicator that compares a security's closing price to its price range over a given time period. The indicator's sensitivity to market movements can be reduced by adjusting the time period or by taking a moving average of the result.
Average True Range (ATR)	A measure of volatility whereby the indicator is the greatest of the following: <ul style="list-style-type: none">- current high less the current low;- the absolute value of the current high less the previous close;- the absolute value of the current low less the previous close;
Bollinger Band	A band plotted 2 standard deviations away from a simple moving average.
On-Balance Volume (OBV)	A method used in technical analysis to detect momentum, the calculation of which relates volume to price change. OBV provides a running total of volume and shows whether this volume is flowing in or out of a given security.
Support	The price level which, historically, a stock has had difficulty falling below. It is thought of as the level at which a lot of buyers tend to enter the stock.
Resistance	The price at which a stock or market can trade, but not exceed, for a certain period of time. Often referred to as "resistance level".
Reversal	A change in the direction of a price trend. On a price chart, reversals undergo a recognizable change in the price structure. An uptrend, which is a series of higher highs and higher lows, reverses into a downtrend by changing to a series of lower highs and lower lows. A downtrend, which is a series of lower highs and lower lows, reverses into an uptrend by changing to a series of higher highs and higher lows.
Divergence	When the price of an asset and an indicator, index or other related asset move in opposite directions.
Overbought	In technical analysis, this term describes a situation in which the price of a security has risen to such a degree – usually on high volume – that an oscillator has reached its upper bound. This is generally interpreted as a sign that the price of the asset is becoming overvalued and may experience a pullback.
Oversold	A situation in technical analysis where the price of an asset has fallen to such a degree – usually on high volume – that the oscillator has reached a lower bound. This is generally interpreted as a sign that the price of the asset is becoming undervalued and may represent a buying opportunity for investors
